
Always test on an inconspicuous area prior to use. Read entire label prior to use. **Dilute product 1:1 ratio with water and follow the applicable directions below.** 

**GENERAL USE:** Apply diluted product with a clean cloth, sponge or mop on mold and mildew stains. Allow product to remain on treated area for 3 - 5 minutes, then wipe with clean cloth, sponge or mop, rinse with water. For heavily contaminated areas, light scrubbing may be required.

Next, treat with Moldstat™ Step 2 Mold & Mildew Disinfectant (an EPA registered product) to remove and inhibit mold and mildew. Then, apply Moldstat ™ Step 3 Mold & Mildew Protector (an EPA registered product) to provide an invisible barrier of protection against mold and mildew.

**RESTROOMS & SHOWERS:** For porcelain, fiberglass and stainless steel bathroom fixtures (toilets, urinals, sinks, tubs, etc.). Apply diluted product directly on surface and rub with sponge or cloth. Rinse with clean water and allow to air dry or wipe dry with a clean cloth.
